Accountability



The CAIS Module

The CAIS module can be used independent of Oyster Solution's CAT Application to view CAIS reports and the underlying source data in a single platform. This module allows firms to better prepare for Full CAIS reporting through the Interim Reporting Obligation. This module uses web-based GUI that provides firms with practical data so users can efficiently identify, monitor, and manage errors which may impact their reports.
